- 1. Attended the County Fire Chiefs meeting in Rohnert Park Public Safety headquarters. A lot of discussion was given to the Study session on July 1^{st} . Some of the goals are as follows:
- * Have the individual regions identify how they can operate as a regional fire agency, what gaps this creates and identifying how to fill these gaps with a target date of this fall.
- * Create a county -wide volunteer stipend program that includes a baseline level of training.
- * Establish a more unified voice to communicate messages to the BOS.

Some solutions as to how this may play out are as follows:

- * Merge the districts and CSA 40 departments
- * Develop a reasonable delivery model for a regional districts
- * Determine the costs of the plan
- * Identify the Ad valorem tax the district would generate.
- * Identify any shortfalls
- * Negotiate with the County an AB8 rate to fill the gap
- * Bring the cities into the process (were applicable)
- 2. Attended the Fire Advisory Council, which carried most of the same discussions . We are working on a presentation for the BOS for their September meeting . Taya Levine is assisting with this.
- 3. Staff meeting with employees and officers. Letters have been sent to non active volunteers, we are tightening up the residence policy, LED lights are being installed during shift where they can without a lift. We will need to rent a lift for the apparatus bay lights. Sean brought three new volunteers in, two have some experience, the third will go through his training possibly looking at a career in the fire service. One of the new recruits with experience

will be taking up residency in our apartments, this makes us full again. The other recruits do not live in the district but will help with our staffing.

- 4. August staffing had eight days with one slot open the last week of July.
- 5. The board should discuss what they think the purpose of county fire should be. I have my opinions but I want to make sure that when I speak it is the board voice I am forwarding.

 - Director Peterson advised the Board that since the BBQ is over, he will be making an appointment to have the floors cleaned.
 - He also advised the Board in checking the storage tanks, he found that the ivy needs to be removed. Chief Mulas will make an appointment for this to be done, and then Captain Garner will run tests on the water to check the PH.
