MEETING MINUTES Schell-Vista Fire Protection District Board of Directors Regular Meeting

Date: February 1, 2017

1. CALL TO ORDER / ROLL CALL

Director Kruljac called the meeting to order at 7:00. Directors Ernie Loveless, Bob Kruljac, Ken Finn, and Hal Stober were present. A quorum was met. Chief Ray Mulas, and District Accountant Robin Woods were also present. Director Joe Petersen and District Accountant Stacie McCambridge were absent.

2. PUBLIC COMMENT PERIOD

There were no public comments.

3. CONSENT CALENDAR

a. Approval of minutes from the January 11, 2017 meeting- Action

Director Finn made a motion to approve the minutes of the January 11, 2017 meeting. There were no comments. Director Stober seconded the motion. The motion passed and the minutes were approved

b. Review of the February Financial Report. Action

Director Loveless made a motion to accept the Financial Report as presented. Director Stober seconded the motion. The motion passed and the financial reports were accepted

4. CHIEFS' REPORT

a. Department Issues

Chief Mulas informed the Board that \$10,000 was transferred from the Exchange Bank Bond account to US Bank to fund the Bond Expense Accounts and \$100,000 was transferred from the District Money Market Account to the District checking account to fund future payables.

Chief Mulas informed the Board that through the Fire Advisory Committee the District will be receiving about \$27,000 along with \$22,000 for Dispatch reimbursement.

b. Department activities

Chief Mulas distributed a memorandum to the Board updating them on the resignation of Engineer Mosley and the steps being taken to fill the position. The tentative start date will be March 16.

Chief Mulas and Director Loveless will meet with the County regarding inspections to obtain a log of what inspections have been done and their details.

He presented Resolution Number 2017-02-01, initiating proceedings with the Local Agency Formation Commission of the County of Sonoma for Amendment of the sphere of influence and reorganization of certain territory currently within County Service Area #40.

Director Loveless made the motion to approve Resolution #2017-02-01. Director Stober seconded the motion. There was no discussion or public comment. The motion was approved by the following vote:
