b. Review of the April 2021 Accountants Report-<u>Discussion and Action</u>

Director Kruljac made a motion to accept the Financial Report for April 2021 as presented. The request for public comments was made. There were no public comments. Director Stober seconded the motion. The motion passed, and the Financial Reports were approved.

#### 5. CHIEFS' REPORT

Chief Mulas presented the following report:

- 1. Station one had a roof leak in the medical room, there was some sheet rock damage that is being repaired. I contacted Ed Salmon Construction and he submitted a quote of \$3100. for repairing all the roof vents that had silicone on them and any flashing that was leaking. I accepted the quote and repairs have been done. We also had some issues with our septic system at Station One. Wine Country Sanitary repaired the stuck on/off switch and later pumped the solids tank and flushed the system after it became blocked.
- 2. Our participation in the Covid Program has come to a close. This was a vary successful joint effort by all agencies.
- 3. Assistant Chief Mike is working with the Sonoma Raceway and other agencies on this years Reduced Crowd for Nascar. He has informed me that there will be some price increases per our Cal Oes rate.
- 4. Our new SCBA's have arrived, and we are currently training with them, they will be put in service as soon as they are labeled and tagged.
- 5. We have put Vector Solutions into play with members of the Department with the first roll out of the Sexual Harassment course. All personnel have until April 4th to complete this assignment.
- 6. We have just had our hose tested and all passed.
- 7. The payment for the Glass Fire has come in for \$ 211,880.23, with the Slatter Fire is still outstanding at \$110,713.19
