Chief Mulas presented the following report to the Board:

- 1. All personnel will now be held to the CALOSHA standard for Covid that the Governor released with a start date of September 5th. All personnel must have proof of their vaccination by the 5th, anyone not having a vaccination will be tested weekly and all personnel must wear a mask at all times while on duty.
- 2. Captain Garner has received another grant for \$150,000 which will be used to upgrade our Mobil Radios. He recently met with Mr. Kevin McNeilly who manages the the fund that presents the grant foundation.
- 3. Our permit has been approved for the fuel tank, so we are getting bids for the job. I have gotten a price for a used tank from our fuel supplier for \$4000.00
- 4. Station one's septic alarm was activated and reset. I called Wine Country Sanitary and they responded immediately. We replaced the pump in the water side.
- 5. 3882 is out of county on the Caldor Fire.
- 6. Ron Rogers, a longtime supporter of the Fire Department and the Volunteers Association, is going to throw himself a Retirement Party and asked if he could hold it at the fire station. I told him I would bring it to the Board.
