#### 5. CHIEFS' REPORT

Chief Mulas presented the following report:

Financial Reports were accepted

- 1. Update on Captain Andersen has not changed. I believe he is seeking another opinion. We have put together an application for Fire Captain in the event we have to hire a replacement for Captain Andersen. If not, we may hire a part time cover Captain.
- 2. I was notified by Lexipol that all county fire departments will have their Lexipol memberships paid for with a start date of February 2,2020. Those of us that have already paid will receive a prorated refund on the time not used. The budget committee has a couple of policies to review and whether they fit into our budget planning process.
- 3. As you all know measure G did not pass, so what is plan B? As of the last Chiefs meeting there is no back-up plan B. The Board of Supervisors did not want a back-up plan. The was no discussion on the subject other than the consolidating projects were going to keep moving forward and the chances of them getting funded are first completed first funded. It is presumed the county will continue to fund the remaining VFC's on the bare minimum, all speculative at this point.
- 4. We have put in place a policy regarding our medical responses during the Coronavirus pandemic. This is a shared policy from Petaluma Fire and is now being shared across the counties of Sonoma, Marin and Solano.
- 6. I will be asking the board for an approval of the bid for sealing and restriping of Station Two. The estimate from strip and seal is \$4070.00. The bid will be available for review at the board meeting.
- 7. I forwarded our expenses of the annexation to Steve Akre and the FWG as they are trying to keep the county on track for our reimbursement. This is the second time the county has seen our costs.

  Fire House Subs \$25,000 for Explorer Turnouts
  Landmark Vineyards \$3,500 for personal flashlights
  Looking for a grant for active shooter equipment for Bob Armanino. This grant could be \$15,000.

Jim and Mike have put in for CalFEMA reimburstment for the October wind events in the amount of \$155,000.
