5. CHIEFS' REPORT

Chief Mulas presented the following report to the Board:

1. During this past series of fires in Sonoma county we committed three engines twelve personnel and rented Calfire 3821 for their division group supervisor. All equipment went out early or late on the 27th, 3874 went out on a strike team while 3882 and 3861 went out on two different all calls. Units 3882 and 3861 were released yesterday while 3874 is still assigned to the Glass incident.

There was some damage to the some of the engines but most all have been repaired in house. The hardest hit was 3874 which had a tree branch come down it's Left rear cab door all other repairs where belts hoses and tires. Some of these damages will be billed to the incident.

Between the labor for the Strike Teams and the shift coverage along with additional Red Flag staffing we may see our labor get out of line at least until we receive our reimbursement funds.

- 2. Our new Captain John Bragg has completed and passed his background, his start date will the first of the month.
- 3. The bathroom remodel at Station 2 is being held up due to the fires. We also have changed vendors for Pest Control at the Stations and the Residence. The reason for the change was poor service.
